



Typical components of a Tender / Request for Proposal (RFP):


- Mandatory conditions for bidders to participate in the Tender
- 2. General Conditions of Contract (aka Terms and Conditions / T&Cs)
- Detailed Scope of Work: Standards and specifications to be met, schedule / milestones / frequency, individual tasks, deliverables / expected outcomes
- 4. Estimated demand /quantities
- 5. Term of contract
- Blank pricing model to be filled in by bidders

- 3. Pricing Model
- 4. Various Annexes /




